





# 10.30 Start of the meet ng

After the introduction and getting to know one another, the meeting started with a presentation about the Connect-Act Youth project. Mr. Mohammed from Solidarity Tracks presented the project about, its aims, project's plan for 2023 and the working plan for the rest of the year.





### Summary and the topic of the Project

The project aims to establish 3-year Framework Partnership Agreements with European Civil Society Organizations to promote youth policy transfer, learning, and support on EU objectives among stakeholders in participating countries. This cooperation will help create a sense of ownership in EU actions and policies, considering civil society's ideas and concerns. The project will enhance civil society involvement in the Erasmus+ Programme, the European Solidarity Corps, and other EU programs, and disseminate youth policy, program results, and good practices among stakeholders through their networks and beyond.

The topic of the project is cooperation with civil society organizations in the field of youth. Cooperation with civil society organizations is crucial for raising awareness about the EU Youth Strategy and the European Year of Youth, providing the Commission with analysis and advice on youth priorities, and achieving the principles of youth participation in democratic life outlined in Article 165 of the Treaty on the Functioning of the European Union and the EU Youth Strategy.




### **Objectives of the Connect-Act Youth project**



- The project aims to enhance the technical and pedagogical skills of youth workers and partners, particularly those with limited opportunities, through a project network that promotes lifelong non-formal learning, tools, and European mobility activities.
- The goal is to collaborate with public authorities and EU programs targeting young people to enhance their influence on local, network, and global political agendas, aligning with the European Year of Youth objectives, focusing on young people's engagement in creating and managing spaces.
- The goal is to enhance the cooperation and commitment of European civil society actors to promote young people's participation in democratic life, and social inclusion, and adapt to the green and digital transition, in line with the EU Youth Strategy.
- The network aims to provide more opportunities for young people, including those with limited opportunities, to participate in learning mobility, both on-site and remotely, to enhance their skills and initiative through exchange with EU youth.
- The aim is to enhance young people's engagement in active citizenship and democratic life in the EU by involving them in the creation, animation, management, and operation of virtual and real spaces.

In addition to the 3-year project plan, Solidarity Tracks also shared the activity plan for 2023, and we talked about what was done and what the results were. After this, a presentation about the Connect Act Youth research report, webinar evaluation report and interactive research report were made. In this presentation, we saw how many people attended this research, why they are important to us and for the project, and what we observed about attendees and the future of this project. Before taking a 10-minute break, participants of the statutory meeting gave their feedback about the researches that was done.

### **Activity Plan for 2023**

### 1. Coordination and project management

- Interactive research study: The study aimed to exchange realities about managing spaces for young people through interactive research, by analyzing real-time data to determine the needs of young people and youth support workers for creative spaces.

- Three online statutory meetings: 2 hours / network meeting were dedicated to follow the activities and results of the project. Partners met to exchange good practices, follow-up, evaluate the progress of the working plan and discuss new initiatives.

- 1 statutory meeting (mobility activity): 3-day network meeting in Italy organized to follow the activities and results of the project. Partners met to exchange good practices and follow up with project activities. This meeting was partly devoted to the analysis of the results of the interactive research and the dissemination of the European Youth Strategy. During this meeting, we exchanged the methods and initiatives related to creating and managing youth spaces in the communities of the partners.
- A final network impact assessment report: A digital report was prepared and shared in English by our team with the contribution of all the partners of the network about the contribution for virtual and physical youth spaces, as well the involvement of youngsters in this process.

### 2. Strengthening the capacities of network members to create and manage youth spaces

- Seminar in Greece on the creation and management of real and virtual youth spaces by and for young people: 2 youth workers per partner country of the network, to develop their skills and strengthen lasting partnerships for the creation and the development of future Erasmus+ projects. Tutorial videos and 3 online training modules resulted from this training to support youth leaders and their young targets in the creation and management of real and virtual youth spaces (September 2023). ### 3. Connecting, engaging and empowering young people

- 2 Focus group (Remotely or on the spot) carried out by each partner at the local level, involving young people of different profiles and capacities to determine their vision on the management of their spaces, in collaboration with representatives of public authorities to encourage policy agenda decisions in favor of and agreement with youth, at least 15 young people, 2 tutors, one project coordinator, one policy maker (each partner)
- 2 E-trainings of young multiplier tutors in the creation and management of youth spaces (Solidarity Tracks/ Coordinator)
- 3 Youth initiatives: Civic and/or entrepreneurial initiatives in favor of their community via our learning platforms mentioned above, initiatives as a local active citizen or European volunteers in favor of their host communities, initiatives for the creation and/or management of a real or virtual youth space, allowing the transmission of the voice of youngsters, fostering their inclusion and creativity. - Impact report: of the network's activities in 2023 (Solidarity Tracks).







Then e-magazines were introduced, and former editions were shown and talked about how they were prepared. We talked about what are they about, their content, their target audience and where they are published. In the presentation, it mentioned that the first edition is dedicated to the network parties and there will be a fourth edition that is planned for 2023.

Before closing the morning meeting and lunch, some plans for 2023 were shared. For the last month of 2023, all network parties must prepare an article for the fourth edition of the emagazines and add 3 locations on the GIS MAP in three categories which are activities, events and services.



# After lunch, we went to visit the Etimesgut Turkish History open-air museum:













Visiting the Etimesgut Barrier-free Living Center for people with disabilities, which is managed by the Etimesgut municipality. In the center, an officer presented us the center, when it's opened, what are they doing, what kind of services they provide, how the disabled people can join and benefit from the center, etc. We learned that there are approximately 52 teachers, workers and other specialists who work here (Psychologists, social workers, cook...). They have a lot of educational areas for different types of disabilities like educational classes for visually-impaired, hearing-impaired (etc.) people. In the center, there are also some other classes like candle making, visual arts, drama, science, music and practice rooms. Most of the classes are for learning practice like bookbinding or candle-making classes and some are for learning daily chores like a practice room. In this room, people learn basic household chores like vacuuming, washing the dishes and/or making their beds. They also learn some basic self-hygiene in this class like brushing their hair or clipping their nails. They also have a gymnasium for physical therapy and a library as well. After we toured the center we met with the center's principle and had a short meeting in the library about Connect Act Youth project, learning more information about the center and future project ideas.



























We also had a meeting with a local decision maker from the municipality, who expressed an interest in cooperating to give young people from the center the chance to take part in mobility schemes under the Erasmus plus programme. We also discussed with the elected official the region's policy for managing spaces for young people. The conclusion of this discussion was that the prefecture of the capital "Ankara" is making every effort to set up and run youth centers and support centers for the disabled that meet the needs of the young people targeted.



After the center, we went to visit the Association of Academic Union and continued working there. In the Association every participant made their presentations about their NGOs, what are they focusing on and doing, what are they doing for youth projects and volunteering programs under the Erasmus+, what they did in 2023 under this project and what were the results of them.

We also talked more about the research results, and the youth's suggestions/recommendations based on the results. After the presentations, feedback was given and each party asked questions if they had any and we finished for the day.


A group of youth workers joined this webinar in the statutory meeting participants and after the presentation, they gave their feedback about the webinar and its efficiency for them. The webinar being online really helped because they were attending the webinar from different countries but also ineffective for them because they preferred more practical activities to learn. After the feedbacks, we examined some e-learning platforms from the eyes of the admin. We examined how to create a course on the website, how to specialize it; how we can see the results of that course's participants, how we can turn them into different diagrams; how to use GIS MAP etc.

When the presentation ended we gave 10 minute break and started the second part. In this second part, all participants made presentations about their NGOs' e-learning projects and their target audience, what are they expecting from these projects, how it is useful to today's world, what they are expecting to achieve, etc. After the presentations, we did one last presentation about the Connect Act Youth project's 2024 working plan. 2.4 Activities to support digital transformation and education

- •Manage, update and improve existing digital educationnal tools, created by the partners by involving resource persons, members of the network, so that they meet the needs of the target audience (young people/educators of young people) such as the existing virtual spaces: Yes club (www.youtheclub.eu) / RESCUE (www.erescue.eu)/ Sport social act (www.sportsocialact.com) / Multicultiart (www.multicultiart.org) / E-ESC (www.e-esc.eu).
- •The beneficiaries of trainings continue to carry out their role as Etutors on a voluntary basis for the platforms indicated above.
- 2.5 A virtual toolfair: involving staff and educators of the network to exchange and experiment with innovative tools and methods (facilitation of virtual workshops) to promote EU actions and opportunities for youth, following the youth objective of Connecting the EU to Youth.



### Work package 3 - Connect, engage and empower EU young people:

- ${\bf 3.1}$  Fostering connections: Mobilities and exchanges between young people in the EU
- •Coordination, hosting and supporting of European volunteers as part of the European Solidarity Corps program. At least 30 volunteers to be involved by the members of the network, to set up civic activities on the following topics: protection of the environment, education in social entrepreneurship, circular economy and employability of young people, promotion of cultural and natural heritage, support and guidance for vulnerable people.
- •Supporting the conception and implementation of Solidarity project that will be initiated by young people from the communities of the network.
- •Design and implementation of youth exchanges involving young people with fewer opportunities on the following themes: inclusion of young people through theatrical practices (Poland), Tutorial videos as a Tool to promote active citizenship and the six core EU values that form the basis of our society (Greece).

- $\cdot$  2 "Focus group" per partner on the involvement of local young people of different profiles and capacities:
- $^{\circ}$ The 1st focus group aims to awareness youngsters about the importance and the value of their participation in the European elections 2024 and how to become multipliers among their peers
- The 2nd focus group will refer to the research that we did in 2023, and aim to design their plan on the management of their spaces, in collaboration with representatives of public authorities in order to encourage policy agenda decisions in favour of and in agreement with youth.
- 3.2 Activities to strengthen the employability, autonomy and skills of young people
- •E-training of young multiplier tutors for creating and managing youth spaces and followup of the e-learning platforms about spaces management "e-rescue.eu" and our platform about social entrepreneurship: youtheclub.eu
- •Youth initiatives for the creation and/or management of a real/virtual space. Initiatives can be civic and/or entrepreneurial for sustainable development and awareness of environmental protection, allowing youth to transmit their voice, promote their inclusion and participation and increase their creativity.







### Work package 4 - Communication, visibility and dissemination:

- 4.1 Develop a professional, user-friendly interactive database that serves as a hub for all your network's activities. Include detailed project descriptions, impact reports, and news updates.
- 4.2 Establish a strong presence on major social media platforms, including Facebook, LinkedIn, and Instagram. Regularly share updates, images, and stories about the activities of our network.
- 4.3 The creation of 4 E-magazines, one per quarter, presenting the activities, news and innovative initiatives of the network members, resources and educational tools created, initiatives taken by young people in terms of creation and management of spaces and other initiatives taken in favor of their community and elsewhere, results of the mobilities for young people and youth workers implemented by the network, initiatives and political decisions in favor of young people in local national and EU level, news about the physical and virtual spaces of youngsters, educational resources to raise young people's awareness on European values and the importance of taking part in the 2024 European elections.
- 4.4 Create a tutorial video to raise young people's awareness of the value of the European elections and the importance of taking part in them.
- 4.5 A remotely European Forum on youth engagement for the management of their virtual and/or real spaces, involving young people, educators and decision-makers from network members (including 2 participants from the focus group activities by each partner). The event will be focus on one of the topics related to the EU priorities. The aim is to show the impact of Erasmus+ projects and share experiences of the programme. (This event will be carried in the European Youth week)
- 4.6 Creating a video summing up the network's activities in 2024 (sharing this video among the network/promoting in a large scale)
- 4.7 Administration and updates of the content of our network GIS map created in 2023 with the aim to exchange and promote youth work good practices, initiatives taken by the youngsters, youth workers and the NGOs of our network.





In the beginning of the afternoon of the 2nd day, we did the activity Open Space for future common projects.

Here is the sum up of the proposals of our partners:
